- In full swing, being deliberate and slow in methodology
 - This means we are going department by department, research program by research program (federal programs with large amounts of IT systems) and we are fully engaging with researchers
 - Have migrated some already, will be continuing to notify department heads to let them know we are coming to speak with their researchers about migration
- Four Tasks
 - Do they have the ability to get local admin access to research program equipment/ resources?
 - Collect inventory of those systems and resources
 - Required to put monitoring tool on them, this is to make sure they have compliance baselines in places for security/federal regulations
 - Inform researcher of the things they need to be doing in research program, make them aware so they can be compliant
