


Item 1: Approval of Minutes

Item 2: New Business / Special Topics (15 mins)

- DIR released Texas Security Controls Standards Catalog 2.0
 - Version 2.0 aligns with NIST SP 800-53 Rev 5
 - o 27 new controls that have been added
 - Control families have been changed up
 - Control 2 is getting a lot of attention
 - Multifactor Authentication for non-privileged accounts
 - Baseline is set at low, meaning low risk scenarios fall within this control
 - Waiting on more clarification
 - Meaning this will be more complex
 - DIR Control Catalog does not incorporate any privacy controls
 - Note: TAMUS now references one privacy control and may include additional in the future.
 - o TAMUS incorporation of DIR Catalog 2.0 will go live March 1
 - Several controls were re-numbered to algin with Rev 5 control families
 - TAMU IT Control Catalog Alignment have reached out to Adam Mikeal for approx.
 timeframe
 - Have not heard back from them yet
 - Stay tuned...more to follow...
- CoALS Server (02) Migration / Remediation Planning
 - Gene and Jeff created very helpful and informative detailed excel list of timeframe, services, dependencies
 - Show we are migrating the services, clarity on where we are headed and the challenges the fall with getting into compliance

- A new Electronic and Information Resources (EIR) Accessibility Awareness TrainTraq course (2114218) has been launched by the System Office.
 - The course is the result of a collaboration of EIR accessibility coordinators, training specialists, and instructional designers across the A&M System
 - The launch is an important step in reducing risk and reinforcing our commitment to access for people of all abilities
 - Accessibility required for everything where there is a human interface, presentation, etc.
 - It will be required for all employees, including student workers, beginning Fall 2022
 - Will show up in TrainTrag, announcement will be made about it
- AIT Information Security Program (WISPP) version 2 update
 - Documenting Defense in Depth strategy
 - Documenting what everyone does, not just IT security staff
- Reminder of upcoming TAMU IT FY 22 annual Risk Assessment
 - o No response on date yet, no report for Fiscal Year 21 as well
