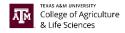

i. There are multiple systems are in use across the university and trying to consolidate to one platform.

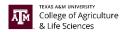
ii. Teams phone has been the most liked after they have done research

### Item 3: Classrooms & Teaching Labs

Description:

General updates and discussion for departmental classrooms and teaching labs and classrooms across the college. - Jake Baumann

- Email was sent out to committee members with CAF Funding Requests PDFs
  - CAF (Computer Access Fee) Funding Requests
    - o BAEN
      - Computers are 4+ years old, but a handful are still under warranty.
      - Jake suggests that him and his team fix things under warranty but wait to satisfy request till after all the others currently in line.
    - o ANSC
      - Jake Baumann recommends this needs to be funded first
      - Requested to replace an undergrad lab in the Kleburg building
      - 20 lab computers, 1 instructor computers, new projector (all of which haven't been touched on since the pandemic). Half of lab is completely unfunctional or out of warranty
      - Hundreds of students take required classes that use this lab
    - o RWFM
      - Jake mentions this request should be approved but action will be taken after ANSC's request
      - They want to broadcast dissections in microscope, not able to do this and display for students. They currently have to have students come up one by one and look through microscope



- AGEC
  - Room is not used as often; students often bring own devices so Jake Baumann recommended to hold off on satisfying their request till after ANSC and RWFM
- Motion to Approve or Reject
  - Requests are all approved
    - Priority- start in ANSC, then RWFM, AGEC, and BAEN

  - ADS is owned by TAMU IT, we were being charged over \$75,000 a year for file storage services

#### Item 7: AGLS Domain Decommission

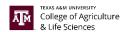
Description:

### Item 8: Introduction to Inventory Dashboard

- This issue needs to be communicate in the departments
  - 60% of staff computer systems/devices across departments in college are not capable of supporting Windows 11
  - TAMU IT said they will block any system that is not upgraded to Windows 11 by October of 2025
  - o Means we have 3 years to get these systems updated and capable of



- going to Windows 11
- Need departments to start tracking this and find out what their current situation is and what budget is needed to have these systems upgraded. Look at dashboard and start identifying which systems need this
